

#### Trafficking in Human Beings is a social evil that is constantly increasing.

The United Nations estimates that human trafficking moves between 5 and 7 billion dollars every year, and that **some 4 million people** find themselves displaced from one country to another.

Drug trafficking and human trafficking are within the **most lucrative crimes**, representing roughly 1.5% of the GDP on a global scale.



**GENDER OF VICTIMS** 




The United Nations estimates that today boys and girls represent one-third of detected victims, and that of every 3 under-age victims, 2 are girls and 1 is a boy.

According to the United Nations, Spain is one of the main destination countries for victims of human trafficking for the purposes of sexual exploitation.

#### **Gender Perspective and Human Rights Approach**

The Trafficking of Human Beings is a grave human rights violation.

It is calculated that between 40.000 and 50.000 women and girls are victims of human trafficking, originating from Sub-Saharan Africa, countries in the East, Brazil and Central America.

# human rights

2.500.000 people are subjected to slavery, of which 56% are victims of sexual exploitation.

#### **Specialized Organization for Minors**

Specialized organizations, like APRAMP, have **holistic resources** which are referred to victims, such as:

- Safe and specialized housing.
- Health, psychological and psychiatric services.
- Social and Educational and resources and training.
- Resources for social and labor insertion.
- Legal aid services.
- Interpretation services.
- Programs for voluntary return.


### assistance

- •services are adjusted to the individuals, not the other way around,
- •flexible hours, central headquarters, 24-hour helpline,
- •mobile units present in the areas where sexually-exploited individuals and/or victims of trafficking can be found,
- •adapted services to their native tongue and customs through the social and cultural mediators who are survivors of trafficking themselves.



### Holistic

- •We empower individuals, boosting their personal, social and economic autonomy.
- •We carry out activities and training for professionals.
- •We cooperate with the Authorities on behalf of victims and we demand the State to meet their social obligations.




### intervention

APRAMP offers specialized care centered on the promotion and advocacy of women and children's' human rights, and seeks to raise awareness and inform society of this type of slavery.

Our mobile unit and trafficking survivors carry out fundamental work in order to detect under-age victims of human trafficking.




The trafficking survivors, trained in mediation, who explore, detect and free minors, obtain valuable information



APRAMP is a non-profit, non-confessional and nonpartisan organization whose principles and philosophy of intervention are oriented by a human rights and gender perspective.



Whoever might know, for whatever reason, of the existence of a potential human trafficking crime or of a possible victim of trafficking, should file a report before the prosecuting authorities, the competent judicial body or police in accordance with the Code of Criminal Procedure.
